By downloading or using the Trax4™ app, these terms will automatically apply to you. Please read them carefully before using the app. Do not copy or modify the app, any part of the app, or our trademarks in any way. Do not attempt to extract the source code of the app, translate the app into other languages, or make derivative versions. The app itself, and all the trademarks, copyrights, database rights and other intellectual property rights related to it, still belong to InterMotive, Inc.

For that reason, we reserve the right to make changes to the app or to charge for its services, at any time and for any reason. We will never charge you for the app or its services without making it very clear exactly what you are paying for.

The Trax4™ app stores and processes personal data that you have given to us, in order to provide our service. It is your responsibility to keep your phone and access to the app secure. Therefore, we recommend that you do not jailbreak or root your device, which is the process of removing software restrictions and limitations imposed by the official operating system of your device. Doing so could make your device vulnerable to malware/viruses/malicious programs, compromise your phone's security features, and could cause the Trax4™ app to work improperly or not at all.
