

## **InterMotive, Inc. Privacy Policy**

This Statement of Privacy applies to [www.InterMotive.net](http://www.InterMotive.net) and InterMotive, Inc., and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to InterMotive, Inc. include [www.InterMotive.net](http://www.InterMotive.net), InterMotive Vehicle Controls, LGS Group and [www.lgs-group.com](http://www.lgs-group.com). The InterMotive website is a product information site. By using the InterMotive website, you consent to the data practices described in this statement.

### **Collection of your Personal Information**

We do not collect any personal information about you unless you voluntarily provide it to us. However, you may be required to provide certain personal information to us when you elect to use certain products or services. These may include: (a) registering for an account; (b) entering a sweepstakes or contest sponsored by us or one of our partners; (c) signing up for special offers from selected third parties; (d) sending us an email message; (e) submitting your credit card or other payment information when ordering and purchasing products and services. To wit, we will use your information for, but not limited to, communicating with you in relation to services and/or products you have requested from us. We also may gather additional personal or non-personal information in the future.

### **Sharing Information with Third Parties**

InterMotive does not sell, rent or lease its customer lists to third parties.

InterMotive may, from time to time contact you on your behalf of external business partners about a particular offering that may be of interest to you. In those cases, your unique personally identifiable information (email, name, address, phone number, physical location and phone status) is transferred to a third party. InterMotive may share data with trusted partners to help perform statistical analysis, send you email or postal mail, provide customer support or arrange for deliveries. All such third parties are prohibited from using your personal information except to provide these services to InterMotive, and they are required to maintain the confidentiality of your information.

InterMotive may disclose your personal information, without notice, if required to do so by law or in good faith belief that such action is necessary to: (a) conform to the edicts of the law or comply with legal process served on InterMotive or the site; (b) protect and defend the rights or property of InterMotive; and/or (c) act under exigent circumstances to protect the personal safety of users of InterMotive or the public.

## **Tracking User Behavior**

## **Automatically Collected Information**

Information about your computer hardware and software may be automatically collected by InterMotive. This information can include: your IP address, browser type, domain names, access times and referring website addresses. This information is used for the operation of the service, to maintain the quality of the service, and to provide general statistics regarding use of the InterMotive website.

## **Use of Cookies**

The InterMotive website may use “cookies” to help you personalize your online experience. A cookie is a text file that is placed on your hard disk by a web page server. Cookies cannot be used to run programs or deliver viruses to your computer. Cookies are uniquely assigned to you, and can only be read by a web server in the domain that issued you the cookie to you.

One of the primary purposes of cookies is to provide a convenience feature to save you time. The purpose of a cookie is to tell the web server that you have returned to a specific page.

### **Security of your Personal Information**

InterMotive secures your personal information from unauthorized access, use or disclosure. InterMotive uses the following method for this purpose:

- SSL Protocol

When personal information (such as a credit card number) is transmitted to other websites, it is protected using encryption, such as the Secure Sockets Layer (SSL) protocol.

We strive to take appropriate security measures to protect against unauthorized access to or alteration of your personal information. Unfortunately, no data transmission over the internet or any wireless network is guaranteed to be 100% secure. As a result, while we strive to protect your personal information, you acknowledge that: (a) there are security and privacy limitations inherent to the internet which are beyond our control; and (b) security, integrity and privacy of any and all information and data exchanged between you and InterMotive through this website cannot be guaranteed.

### **Right to Deletion**

Subject to certain exceptions set out below, on receipt of a verifiable request from you, InterMotive will:

- Complete the transaction for which the personal information was collected, fulfill the terms of a written warranty or product recall conducted in accordance with federal law, provide a good or service requested by you, or reasonably anticipated within the context of our ongoing business relationship with you, or otherwise perform a contract between you and InterMotive;
- Detect security incidents, protect against malicious, deceptive, fraudulent, or illegal activity; or prosecute those responsible for that activity;
- Debug to identify and repair errors that impair existing intended functionality;
- Exercise free speech ensure the right of another consumer to exercise his or her right of free speech, or exercise another right provided for by law;
- Comply with the California Electronic Communications Privacy Act;
- Engage in public or peer-reviewed scientific, historical or statistical research in the public interest that adheres to all other applicable ethics and privacy laws, when our deletion of the information is likely to render impossible or seriously impair the achievement of such research, provided we have obtained your informed consent;
- Enable solely internal uses that are reasonably aligned with your expectations based on your relationship with InterMotive;
- Comply with an existing legal obligation; or
- Otherwise use your personal information, internally, in a lawful manner that is compatible with the context in which you provided the information.

### **Children Under Thirteen**

InterMotive does not knowingly collect personal identifiable information from children under thirteen. In the case we discover that a child under thirteen has provided us with personal information, we immediately delete this from our servers.
